

#### Terms and Conditions for Hack2Win

Welcome to the TryHackMe Hack2Win event! Please read the following Terms and Conditions carefully as, together with our Terms of Use, they govern your participation and interaction with the event. By participating in the Hack2Win event, you agree to abide by these terms. If you do not agree, you should not participate.

### 1. Event Participation Rules

- The event will start at [time] on [date] and close at [time] on [date].
- Users can win tickets by completing rooms in the designated pathway.
- Subscribed users receive two tickets per room completion if a ticket was drawn, while non-subscribed users receive one ticket per room if a ticket is drawn
- Users who subscribe after completing a room will not receive additional tickets for rooms they have already completed. Only new room completions as a subscribed user will award two tickets if drawn.
- Resetting and re-completing a room as a subscribed user will not result in additional tickets if drawn, if the room was completed prior to subscription.

# 2. Viewing and Managing Tickets

- All tickets that a user has earned can be viewed on their dashboard.
- Once tickets are redeemed, they will appear on the user's public profile page. Users
  can access their redeemed tickets by visiting: <a href="mailto:tryhackme.com/profile">tryhackme.com/profile</a> and clicking on
  Public Profile.

# 3. Winning Tickets

- Tickets can be won by completing any room on TryHackMe.
- Ticket are distributed based on a random draw, which is influenced by the rarity rating of tickets. For instance, users are 5x more likely to win a Bronze ticket than a higher-value ticket like Gold.
- The more rooms completed, the higher the chances of filling your ticket stamp card per tier, where you will be placed into the prize draw.

## 4. Awarding Prizes & Redemption

- Once users have added 10 tickets of the same tier (Bronze, Silver or Gold) to their stamp card, users will be placed inside of a draw/raffle for that tier, where winners of each prize type will be picked by random.
- Once you've completed a Bronze, Silver, or Gold stamp card, you're automatically entered into the relevant raffle.
- Bronze prizes can be won throughout the event.
- Silver prizes are drawn on 8 September 2025.
- Gold prizes are drawn on 10 September 2025 10.
- Winners will be notified by email.
- TryHackMe's decision on all matters is final and binding.

#### 5. Streak Freeze Prize

- The Streak Freeze prize protects your hacking streak in case you miss a day. For
  instance, if you have a 6-day streak but miss Day 7, the streak freeze will ensure your
  streak is protected.
- The streak freeze activates immediately and will remain active until it is needed to protect a missed day.

### 6. Response Deadlines for Prize Claims

- If users are contacted via email or social media to claim the prizes they have won, they must respond by the 24th of September 2025.
- When users are asked for their delivery address, they have two weeks to respond so the prize can be sent.
- If a user does not claim their prize, or fails to provide their delivery address, within the specified deadlines for doing so, their prize will be forfeited automatically.

# 7. Prize Delivery and Charity Clause

- We are not liable for any damage or loss to a prize caused by any third party. If a prize is damaged or fails to be delivered, we will have no obligation to provide a replacement prize.
- If a prize cannot be sent to a user's specific address, location, or country, the prize value will be donated to charity.
- If necessary due to circumstances beyond our control, we may (at our option) substitute a prize for a reasonable equivalent of equal or higher value, or a cash alternative.

## 8. Disqualification

• TryHackMe reserves the right to disqualify users and/or revoke tickets and/or prizes (at any stage of the event) if:

- o the user is ineligible or does not meet any of the eligibility criteria; or
- the user breaches any of these Terms and Conditions, our Terms of Use, or any other rules and regulations of the event or violates any applicable laws or regulations; or
- in TryHackMe's sole and absolute determination, it believes that the user has attempted to undermine the operation of the event by fraud, cheating or deception.
- In the event of a disqualification after the prize has been awarded, TryHackMe reserves the right to demand the return of the prize or payment of its value from the ineligible user.
- Whilst TryHackMe will endeavour to conduct necessary verifications on the eligibility of users, failure to disqualify any ineligible users shall not be deemed a breach by TryHackMe.
